You can use both front and back in providing information regarding experience and project related information. The resumes and certificate of insurance is not part of this page count.
- 3. Can you please define "project proposal price" in the first paragraph on the second page and clarify what you are looking for here? Designers have been requested to provide a proposal for services related to the Masterplan. The project will be exempt from the Mini-Brooks Act due to estimated design fees related to the Masterplan and following projects is expected to be less than \$50,000. Please refer to the scope of work in the RFP.
- 4. Do you have a schedule or budget in mind for this effort? As noted above it is estimated that design fees will be less than \$50,000 for the Masterplan and any subsequent construction designs related to renovations. It would be the desire of the Town to have a contract negotiated and issued before the end of January with Masterplan being completed by the nd of February 2019.
- 5. Is there any anticipated site work as part of this effort? Please refer to the scope of work in the RFP. The proposal should consider any site visits and meeting necessary to gather information related to current space and occupation, review with management and directors regarding space need and usage, as well as review of facilities and identification of existing layouts and equipment.
- 6. Are you looking to expand the building or to reorganize the spaces within the building? Please refer to the scope of work in the RFP. At this time the design will be limited to review and reorganization of the
