Dear Sir or Madam,

An onsite investigation was completed on April 7, 2025 following a request for inspection concerning the subject project for the roadway improvements on SR 1003 (Rolesville Road). The investigation produced items, which fell short of NCDOT standards. They are as follows:

- 1. Seal all expansion joints in sidewalk and ADA ramps
- 2. Remove abandoned utility pole from ROW
- 3. Remove dry utility debris from utility strip
- 4. Replace broken sidewalk at appx station 28+00 LT
- 5. Seal weephole in structure 777
- 6. Clean out inside structures 777, 777A, 776, 775 and 774
- 7. Clean out gutter pan throughout project limits
- 8. Repair rutting adjacent sidewalk and within utility strip appx ST 37+00 LT
- 9. All thermoplastic pavement markings must be in place before warranty period begins
- 10. Remove silt fence and grade backslope appx station 37+00 RT to station 22+00 RT
- 11. Remove all conflicting striping from ST 21+00 to ST 24+00
- 12. Remove excess ABC/asphalt debris from ROW ST 31+00 RT to ST 33+00 RT
- 13. Return ditch to existing condition, removing driveway pipes at 1721 and grade to drain each direction
- 14. Grade all ditches to inverts of pipe and clean out driveway pipes
- 15. Roadway certification reports sealed by a Professional Engineer shall be submitted to the North Carolina Department of Transportation at 4009 District Drive, Raleigh, North Carolina, indicating the following:
 - * Pavement thickness by type
 - * Pavement density, core and/or test locations
 - * Base thickness
 - * Base density
 - * Subgrade density to include proofroll
 - *NCDOT certified technicians name and certification number
