## Request for Street Lights in Residential Subdivision

In order to install and/or energize street lighting within your development, this document must be reviewed and authorized by the developer.

Please be advised that no street lights or ground-mount entrance lighting provided by Wake Electric will be energized upon installation of the primary electrical distribution system unless requested herein. If lights are requested, the developer may choose to energize lights at the time of initial infrastructure or at any time after the infrastructure is in place by way of the following request:

I am requesting Wake Electric to install and energize street lights and/or ground-mount entrance lighting as defined below in Wallbrook Phase II /Townhomes development. I understand and agree to pay monthly charges for these lights until such time as charges can either be 1) prorated to residential accounts benefiting from these services as per Wake Electric Service Schedule SL for Residential Subdivisions, or 2) a Homeowners Association agrees to accept the charges by transfer of account ownership, or 3) the governing municipality agrees to accept charges for these lights in Wake Electric Service Schedule OL.

I also understand that charges issued to my account are due and payable as displayed on the monthly bill. Bills not paid by the due date shall be subject for late fees and disconnection.

Note: If lights are expected to be prorated to homeowners, the Cooperative agrees to remove any appropriate charges from this account at the time a service is connected per Schedule SL. However, it is the responsibility of the account holder to contact the Cooperative to ensure charges are removed on a timely basis.



Furthermore, in order to ensure that proration to future homeowners is possible, the developer agrees to install the following clause in the restrictive covenants of this development. Unless this clause is contained within the covenants, no charges can be transferred.

The Grantors reserve the right to subject the property in the subdivision to a contract with Wake Electric Membership Corporation for the installation of underground electric cables and/or the installation of street lighting, either or both of which may require an initial payment and/or a continuing monthly payment to Wake Electric Membership Corporation by each residential customer.
